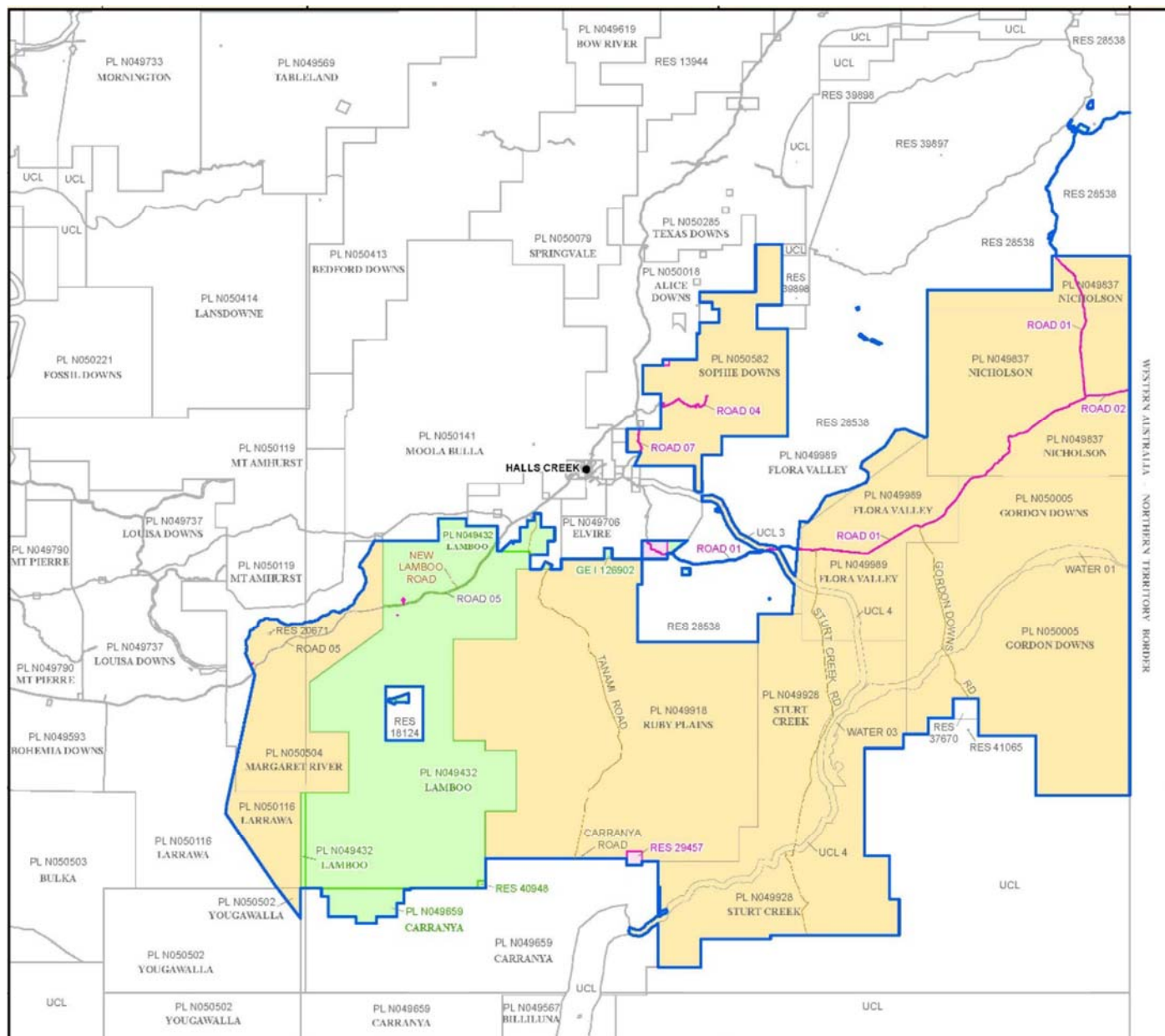

- 1. Family Consultation Meetings** for Jaru native title holders about setting up a Prescribed Body Corporate (“PBC”) will be held on the above dates. These consultations are being held in the lead-up to a meeting of the Jaru native title holders to make decisions about establishing your PBC, to be held on **30 – 31 March 2021**.
- The consultation meetings are being held by the KLC to provide Jaru native title holders with advice on the role of a PBC, options for setting up a Jaru PBC, and to discuss a draft Rule Book for the PBC.
- The family consultation meetings will be held in Halls Creek and Kununurra, and the KLC will contact Jaru native title holders for more details on when to attend the meetings.
- Copies of a draft Rule Book for the PBC will be available for native title holders at the consultation meetings, so that you can start thinking about the rules you want for your PBC.
- These consultation meetings are for information and discussion purposes only, and no decisions will be made at these meetings.
